Right to information application – Overseas Visits and Tours – 2016 – 2017

I refer to the application for assessed disclosure of information made by you under the *Right to Information Act 2009* (Tas) ("RTI Act") dated and received on Thursday 21 March 2022.

1. The terms of your RTI Application

Your request for information was on the following terms:

UTAS' annual report for 2016 includes a statement that:

"Following the visit to King's, the Vice Chancellor and Chair of the University Council's Built Environment and Infrastructure Committee joined with the Hobart City Council to attend the annual conference of the Academic Association Conference, entitled UniversCities - Higher Education Institutions and their Habitat. Following the conference, delegates visited the exemplar cities of Freiburg in Germany and Cambridge in the UK." (p33)

UTAS's annual report for 2017 includes a reference to:

"...a tour for the mayors and aldermen of Hobart, Burnie and Launceston to collaboratively explore how strong partnerships between universities and cities can create social, cultural, and economic benefits." (p30)

I request all UTAS Council and Built Environment and Infrastructure Committee records relating to these two visits/tours ("visits"), including but not limited to:

- proposals for the visits;
- lists of UTAS officers, mayors and alderman involved in the visits/tours ("delegates");
- choice of delegates:
- briefs prepared for the visits;
- reports on/assessments of the visits;
- Council discussion of the visits; and
- the costs of the visits (I would expect these to include line item expenditures, rather than detailed accounts or receipts).

2. Background

The background to this matter is as follows:

- On 21 March 2022 you submitted an application for assessed disclosure of information.
- On 22 March 2022 Mr Parnell accepted your application on the following terms:
 - "records relating to overseas visits/tours by UTAS officers to the UniversCities conference and overseas universities, as reported in UTAS' annual reports for 2016 and 2017."
- On 14 April 2022 Mr Parnell provided you with an itinerary of travel, and confirmed the total cost of travel under the itinerary at Attachment 1 was \$94,455.75.
- On 3 May 2022 Ms O'Keefe wrote to you by email and advised that the University had
 made a decision prior to the receipt of your 3 applications to make a routine disclosure
 of information related to the University's move from Sandy Bay into the Hobart CBD
 within the foreseeable future, and before the expiration of 12 months from the date of
 receipt. Accordingly, the University refused to accept three of your Right to Information
 applications.
- On 3 June 2022 you wrote to the Vice Chancellor requesting Internal Review of Mr Parnell's decision of 14 April 2022.
- On 27 June 2022 Ms Beaumont wrote to you to advise you were out of time to seek internal review of this decision. However, although you were out of time to lodge an application for internal review, we advised you that we were in the process of compiling information to make a routine disclosure of information relating to your application.

We are now in a position to make a routine disclosure of information relating to your application.

The Vice-Chancellor also provided verbal briefings on the UniverCities Conference and associated visits to the Built Infrastructure and Environment Committee University Council and records indicate that findings from the visits would have been presented verbally in other strategic University forums to inform decision making at this time.

Key leaders across the university undertook a trip that covered a number of key strategic and relationship orientated activities. A number of the members of the leadership team only attended parts of the trip that were relevant to their role, which included activities like:

- Securing a partnership with the University Bologna, the world's oldest university
- Hosting an alumni event in London, where the University's alumni award was presented to Brodie Neill
- Pursuing a partnership with the Scripps Institute at UCSD, who is a world leader in marine research and has strong linkages to IMAS
- Learning about effective pathway programs to increase education participation in Tasmania, such as the Freiburg University College (which our own College is also named) and the American College system which has had great success in areas like Georgia and North Carolina

University of Tasmania Vice-Chancellor Professor Peter Rathjen today (Friday, 16 September 2016) signed a Memorandum of Understanding with University of California, San Diego (UC San Diego).

The MoU contains agreement that the universities – both world leaders in particular research fields – will work together on a range of fronts, including student exchanges and research internships.

Professor Rathjen, pictured with UC San Diego's Vice-Chancellor for Student Affairs, Dr Juan González, said the agreement was born of an enduring, growing friendship between the institutions — a friendship based upon reciprocal visits and a mutual interest in research with global implications.

"Through our Institute for Marine and Antarctic Studies (IMAS), the University of Tasmania shares interests with the UC San Diego, particularly in areas such as ocean science, climate and the environment," he said.

"This aligns with the activities and focus of UC San Diego's Scripps Institution of Oceanography, with which IMAS already has strong ties.

"That an academy of global standing, like UC San Diego, chooses to work together with us shows that we are among a handful of organisations which is truly at the upper echelon of the worldwide research community."

UC San Diego was recently placed by the highly regarded international ranking system, ARWU, as one of the best institutions in the world, based on a range of measures including research and graduate quality.

The MoU will lead to consideration of a range of initiatives including the creation of virtual classrooms and laboratory programs, joint degrees and summer programs.

The UC San Diego signing is one of a number of stops on an itinerary which included Europe and the US, during which University leaders examined a number of world-leading institutions and systems. Delegates to the party included Chancellor Michael Field AC, Vice-Chancellor Professor Peter Rathjen and academic and professional leaders from a range of discipline areas critical to the University's future planning and success.

Chancellor Field said investing in such study missions were core to maintaining a world-class, internationally competitive university.

"Universities are part of a global community and, if we are to be among the best in the world, we need to be an active part of that community, establishing partnerships that enable an exchange of knowledge," Chancellor Field said.

"We have an obligation as the State's only university to forge these relationships for both our benefit and Tasmania's more broadly.

"Just last year the University had research collaborations spanning 88 countries which resulted in 1762 publications, something which underpins our position as an institution of world-standing and renown.

"We invest every year in international travel, the majority of which is for academic pursuits funded by external grants and which informs an essential part of our international research collaboration. Along with our international student recruitment, this helps deliver a return of more than \$200 million year on international education for Tasmania, a market we intend to grow in partnership with the State Government to \$400 million.

"We see a future in which a core pillar of the Tasmanian economy is the export of high quality, world-leading higher education at associate degree, undergraduate and post-graduate levels."

Similar visits have been key in informing the thinking behind the University of Tasmania's bold \$300 million transformation plan, which includes the implementation of a new type of curriculum which is more affordable and regionally relevant.

"The ability to come and look at some of the very best working models of these principles in the US and elsewhere, has allowed us to progress to the point of being able to deliver our transformation plans at a rate that would not have been possible otherwise," Chancellor Field said.

PURPOSE OF MISSION:

- To sign a memorandum of understanding with a consortium of four of France's leading graduate schools of Engineering (GEMA), positioning the AMC strategically within Australia's maritime defence capabilities.
- To explore opportunities for connected agriculture in the Champagne-Ardennes region.

The Vice-Chancellor has extended invitations to all Tasmanian Senators.

BACKGROUND

Two key opportunities in France were identified and developed during the Vice-Chancellor's February mission to Europe. The partnership with the GEMA is currently the highest priority, however, the visit offers the opportunity to explore collaboration in the Champagne Ardenne region in agricultural extension.

Memorandum of Understanding with GEMA Consortium

In 2016 the Federal Government announced that the next fleet of Australian submarines would be built in South Australia and appointed DCNS as the design partner.

DCNS is an advanced technology company, the European leader in naval defence and designs and builds sub-marines and surface combatants and develops associated systems and infrastructure as well as support services to naval bases and shipyards.

France is a leader in advanced technology research and development associated with defence industries. The four French parties to the MOU are leading French engineering institutions with expertise in advanced defence and maritime technologies and partner with DCNS in research and development:

- **ENSTA ParisTech** is a French "Grande École" (Graduate School of Engineering) under the supervision of the Ministry of Defence;
- **Centrale Nantes** is a French "Grande Ecole" has developed strength in the field of oceanic and naval engineering based in particular on experimental equipment unique in Europe;
- **CentraleSupélec** is a top French public Institute of Science and Technology, resulting from the merger of the Ecole Centrale Paris and Supélec, it is a founding Member of University Paris-Saclay and leads the Ecole Centrale Group.
- École Polytechnique is the leading French institute which combines top-level research, academics, and innovation at the cutting-edge of science and technology. It has 22 laboratories, 21 of which are joint research units with the French National Center for Scientific Research (CNRS). École Polytechnique is also a founding member of Université Paris-Saclay.

The MOU, to be witnessed by DCNS and a Tasmanian State Government Minister, provides a framework for academic research and cooperation in the disciplines of subsea engineering, submarines, hydraulics, hydrodynamics and wave energy, linked to industry.

Flinders University has entered into a similar agreement with the consortium and will leverage research, research training and technical expertise for the Future Submarine program. The University of South Australia will arrive in Nantes to sign their part of the agreement on March 29 and ECN have asked if it is possible for UTas to sign our agreement before that. UniSA is taking a large contingent but there is no maritime expertise among the academics going to France.

The partnership with French institutions is crucial to Tasmania's ongoing and undisputed global leadership of maritime research and training, and continues the mission of the Australian Maritime College (AMC) as established by the Federal Government as the national centre for maritime defence related research, development and training. There is an opportunity to ensure that the joint programs initiated by UTas are central to the Future Submarine Program as the other Australian universities in the consortium are unable to provide this leadership.

It is intended that the visit to Nantes in March will bring together key professorial staff from AMC with the four GEMA partners and potentially researchers from Brest with whom the AMC have a longstanding partnership. AMC delegates are being finalised, but the delegation would include Professor Neil Bose and Assoc Professor Jonathan Binns. ECN are seeking to establish our interest in the pursuit of a joint research centre in Nantes between the French engineering consortium and the University of Tasmania in these areas.

The University would pursue a parallel partnership with Centrale Nantes to establish joint masters courses. Currently, there are a number of relevant 2 year courses taught in English in areas relevant and complementary to the University's offerings:

- Master of Engineering in Hydrodynamics and Ocean Engineering
- Master of Engineering in Computational Mechanics
- Master of Engineering in Design of Systems and Products
- Master of Engineering in Energetics and Propulsion
- Master of Engineering in Materials, Processes and Technology of Composites
- Master of Civil Engineering
- Master of Engineering in Automatic Control, Signal and Image
- Master of Engineering in Advanced Robotics

 Master Amasone Atlantic Master on Ship Operation and Naval Engineering (Marine and Ocean Engineering).

Students undertaking the degrees will be funded by DCNS and it is envisaged one year will be undertaken in Nantes, the other in Launceston.

Champagne Ardennes

Following on from the meetings between UTas and GEMA academics and the signing of the consortium MOU, the delegation will travel to the Champagne-Ardennes region. The purpose of this short visit is to respond to an invitation to consider opportunities for research collaboration in "connected agriculture," primarily through Sense-T. The Director of Research in Sense-T, Dr. Stephen Cahoon, has been invited and the State Government Minister, if confirmed, will also travel to the region where the Lord Mayor of Chalons has offered to host discussions and will be accompanied by the Governor of the region.
