Right to Information application - Re. University of Tasmania and Robert Hogan

I refer to your request dated 18 August 2023 under the Right to Information Act 2009 (RTI Act) seeking:

- (1) I request the following records in relation to the period 23 November 2022 to 18 August 2023:
 - (a) All briefs provided to Senior Officers (Executives) and Ministers in the Treasury and Finance portfolio in relation to the proposed move of the University of Tasmania (UTAS) into the Hobart CBD and/or redevelopment of the Sandy Bay campus.
 - (b) All briefs provided to Senior Officers (Executives) and Ministers in the Treasury and Finance portfolio in relation to the financial health/situation of UTAS.
 - (c) All analyses undertaken within the Treasury and Finance portfolio in relation to the proposed move of UTAS into the Hobart CBD and/or redevelopment of the Sandy Bay campus.
 - (d) All analyses undertaken within the Treasury and Finance portfolio in relation to the financial health/situation of UTAS.
 - (e) All analyses undertaken within the Treasury and Finance portfolio of UTAS' annual report for 2022 (published 2023).
- (2) I request all records relating to the matter of borrowing approvals and UTAS in the period I January 2022 to 18 August 2023.
- (3) I request all records referring to UTAS' Green Bond either by name or substance.
- (4) I request all records referring to me (Robert Hogan), by name or not.

Following email correspondence with you on 7 September 2023 and 12 September 2023, the request was amended to:

- (1) I request the following records created during the period 23 November 2022 to 18 August 2023:
 - (a) All briefs provided to Senior Officers (Executives) and Ministers in the Treasury and Finance portfolio in relation to the proposed move of the University of Tasmania (UTAS) into the Hobart CBD and/or redevelopment of the Sandy Bay campus.

- (b) All briefs provided to Senior Officers (Executives) and Ministers in the Treasury and Finance portfolio in relation to the financial health of UTAS.
- (c) All analyses undertaken within the Treasury and Finance portfolio in relation to the proposed move of UTAS into the Hobart CBD and/or redevelopment of the Sandy Bay campus.
- (d) All analyses undertaken within the Treasury and Finance portfolio in relation to the financial health of UTAS.
- (e) All analyses undertaken within the Treasury and Finance portfolio of UTAS' annual report for the year ended 31 December 2022 (published 2023).
- (2) I request all records relating to the matter of borrowing approvals and UTAS created during the period 23 November 2022 to 18 August 2023.
- (3) I request all records referring to UTAS' Green Bond created during the period 1 January 2022 to 18 August 2023.
- (4) I request all records referring to me (Robert Hogan), by name, created during the period 23 November 2022 to 18 August 2023.

Your request noted that 'records' is intended to include emails and other forms of electronic correspondence, and encompasses records held by the Treasury and Finance portfolio that emanated from third parties, including UTAS. You request also noted that Senior Officers (Executives) means 'members of the Tasmanian Senior Government Executive Service'.

In scope records identified

Following my preliminary search and subsequent individual assessment of documents, I I records were identified as containing information relevant to your request. The information contained in one of these documents was already publicly available in full on the website of the Tasmanian Parliament. The remaining documents are listed in the enclosed schedule of records (Attachment A), together with my detailed assessment of each record, including any relevant exemption categories and public interest tests that I have applied.

Reasons for Decision

Record I

Record I is a Ministerial briefing compiled to assist the Treasurer to prepare for his appearance at the Legislative Council Select Committee inquiry into the provisions of the *University of Tasmania Act 1992* on 6 July 2023.

I have redacted exempt and out of scope information from Record I in accordance with sections 27 and 39 of the *Right to Information Act* 2009² and determined the remaining information may be released.

Record 2

Record 2 is a timeline of UTAS borrowing activities from prior to 2014 to September 2022.

I have redacted out of scope information and information which is exempt under sections 31, 35 and 39 and determined the remaining information be released.

I have redacted personal information which is exempt under section 36 and determined that the remaining information be released.

Record 8

Record 8 is a draft copy of Record 6.

I have determined that the information contained in this record may be released in full.

Record 9

Record 9 is a letter from the Treasurer dated 4 September 2023 confirming that the State does not guarantee green bonds issued by UTAS.

I have redacted personal information which is exempt under section 36 and determined the remaining information be released.
